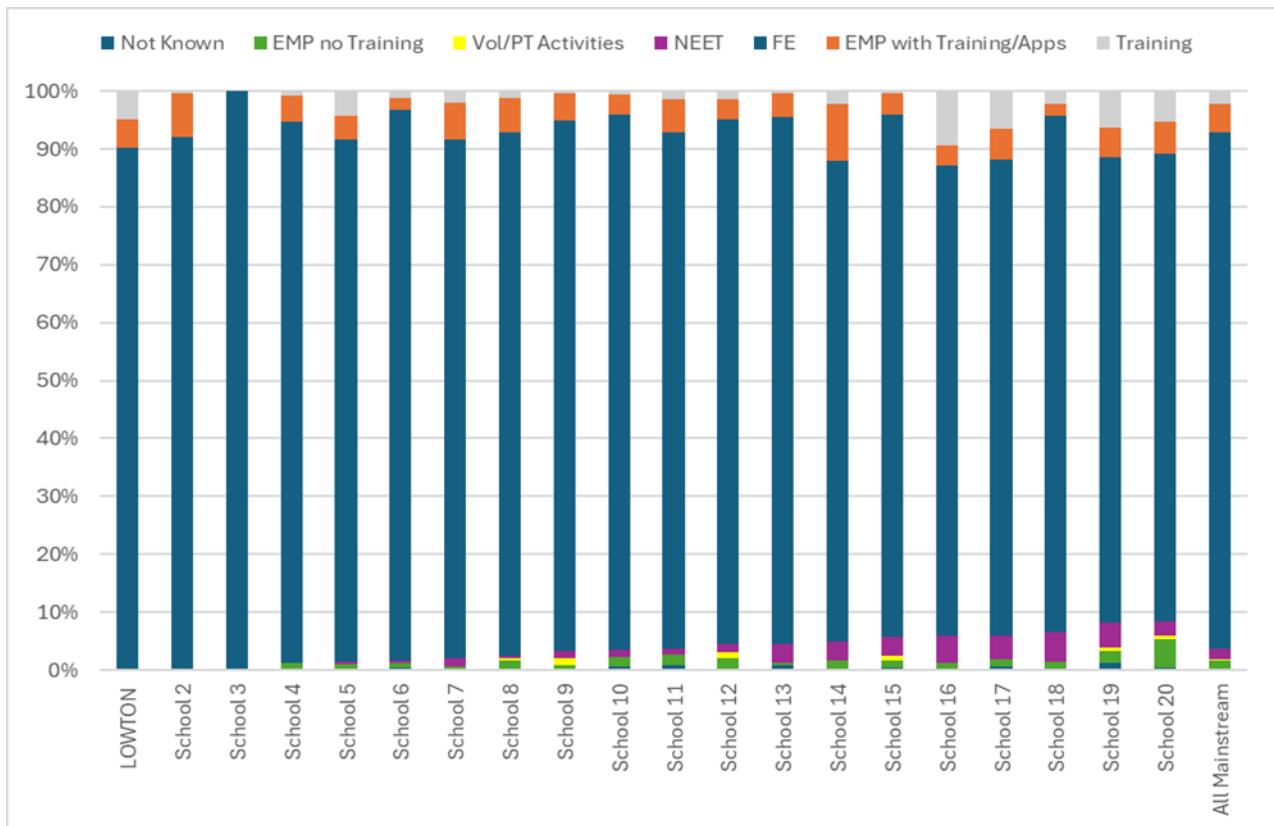


## Activity Survey 2023
